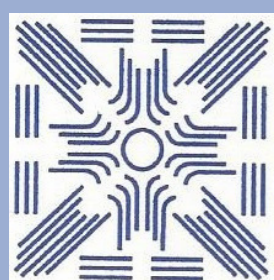

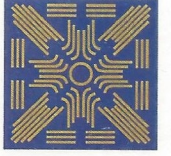

FOREWORD



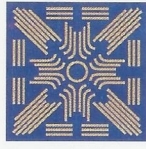

ACKNOWLEDGEMENT


