

## 7. Stakeholder's Workshop

### 7.1 Workshop Objective and Proceedings

A stakeholder's workshop on Counter Magnet Areas to Delhi and NCR was held on 22 Nov 2007 at India International Centre, New Delhi. The major objective of the workshop was to disseminate findings and the recommendations on counter magnet areas to Delhi and rest of NCR and to have feedback from the stakeholder's. The workshop was attended by the concerned officers from the States, central government & NCRPB; experts from the field and the consultants. The Secretary Urban development, Government of India chaired the meeting. In the workshop a detailed presentation was made by the consultants on the counter magnets areas study and its findings. The presentation consisted of three parts.

Part I was on the profile and migration pattern to Delhi and NCR. The major content of the presentation of part I was:

1. Project background
2. Objectives of the Study
3. Profile of NCR
4. Migration Pattern NCTD and other areas in NCR
5. Profile of Migrants
6. Projection of Population and Migration to NCTD and rest of NCR
7. Migration Study – Primary Survey.

Part II of the presentation was on the recommended CMAs. The major structure of the presentation was:

1. Existing Counter Magnet Areas
2. Process for Identification of Proposed Counter Magnet Areas
3. Recommended CMAs
4. Recommendation for Special Package and Existing CMAs

Part III of the presentation was on development strategy for the recommended CMAs. The major structure of the presentation was:

1. Investment Climate in India
2. Investment Climate and Opportunities in Recommended Counter Magnet Areas
3. Strategies for Development in Recommended CMAs
4. Resource Mobilisation
5. Urban Development
