#### NATIONAL CAPITAL REGION PLANNING BOARD

No. A-36024/1/2006-Estt.—In exercise of the powers conferred by Section 32 of the National Capital Region Planning Board Act, 1985 (2 of 1985), National Capital Region Planning Board hereby further amends

Notification No. K-14011/13/85-NCRPB, dated 10.08.1985 whereby financial powers were delegated to the Member Secretary of the Board under Section 22(2)(a) under item III Serial No. 26, by virtue of his being Head of the Department under various Rules. The above said notification has been amended from time to time in the exigencies of public interest by Notifications 14th December, 1987, 4th July, 1991, 9th January, 1997 and 23rd August, 2006 leading to this amendment for enhancing the financial powers of the Member Secretary, which has been approved in the 31st Meeting of the National Capital Region Planning Board, held on 11.11.2009.

This Amendment shall be deemed to have come into force with effect from the date of intimation of approval by the Chairman, National Capital Region Planning Board i.e. 28.11.2009.

The following modifications in the delegation of powers to the Member Secretary for appointment of part-time Advisors/Experts and of in-house consultant on fixed tenure basis have been made :—

- (i) The power delegated to the Member Secretary in 1997 i.e. appointment of part-time Advisors/Experts as approved earlier and notified vide No. K-14011/13/85-NCRPB dated 09.01.1997 is restored. The monetary limit enhanced to Rs. 6 lakhs per case in view of overall increase in costs, remuneration etc.
- (ii) The provisions contained in Notification dated 23.08.2006 will be applicable only in cases where maximum payment per consultant exceeds 6 lakhs per case.

### CENTRAL COUNCIL OF INDIAN MEDICINE

New Delhi-110058, the 8th February 2010

No. 20- 01/2009-CR.. (Andhra Pradesh)—Whereas the Central Council of Indian Medicine has, in pursuance of Sub-Section (1) of Section 23 of the Indian Medicine Central Council Act, 1970 (48 of 1970) is maintaining a register as the Central Register of Indian Medicine which contains the names of persons enrolled on the State Register of Indian Medicine of Andhra Pradesh and who possess any of the medical qualifications recognised under the Act.

Now, therefore, in pursuance of Sub-Section (2) of Section 23 of the Indian Medical Central Council Act, 1970, the Registrar, Central Council of Indian Medicine, New Delhi hereby amends the Central Register of Indian Medicine by including the names of persons subsequently enrolled in the State Register upto 01.04.2006 to 31.12.2007 by inserting Serial No. 119992 of Ayurveda onwards after the existing last Serial No. 120110 of Ayurved which to be published in the Gazette of India for general information.

Note :—While every care has been taken to compile the Central Register of Indian Medicine (Andhra Pradesh) from 01.04.2006 to 31.12.2007 as per Section 23 of the Indian Medicine Central Council Act, 1970, and omission/correction, if any, be reported to the Registrar, Central Council of Indian Medicine, 61-65, Institutional Area, Janakpuri, New Delhi-110058 for rectification of the same in the next publication of the Register.
