Agenda Item no.3: To discuss the request of Civil Aviation department, Haryana for reduction of rate of Interest for the "Project Development of Integrated Aviation Hub, Hissar".

PSMG-I in its 60th meeting held on 15.07.2021 had accorded approval for financial assistance for Rs.700.00 crore on the project proposal "Phase II – Development of Integrated Aviation Hub, Hisar" of Civil Aviation Department, Haryana under Land Development Projects – Residential/ Industrial/ Commercial and other Infrastructure viz. Technical/ Medical Institutions category project at the applicable interest rate of 8.50% p.a. vide Board letter dated 18.07.2016 (Annexure-3/I) subject to furnishing of the following to NCRPB:

- i. SFC approval and
- ii. Adequate Guarantee for the loan {(security proposed to be offered (State Guarantee/ Bank Guarantee @ 133.33 of the loan)} against the loan drawl from NCRPB. In case of direct loan to State Government backed with State Guarantee, an undertaking with regard to budget provision for repayment of loan/interest would be required.

The Civil Aviation Department (CAD), Haryana vide their letter dated 06.10.2021 has suggested that the proposed rate of interest of NCRPB loan may be reduced at par with the market borrowing rate of the Government of Haryana which is 6.90% so far and asked for NCRPB's consent accordingly to accord necessary approval by the Finance Department, Government of Haryana (Annexure-3/II).

Board had communicated to CAD, Haryana vide letter dated 12.11.2021 (Annexure-3/III) and requested to submit the requisite documents as mentioned above for further necessary action for their request regarding lower rate of interest.

Board's letter/circular dated 18.07.2016 regarding revised rate of interest and terms and conditions on Loan Assistance given by NCRPB is placed for the information of the Group **(Annexure-3/I).**

5.1 <u>Asian Development Bank:</u> ADB has approved a loan of US \$ 150 million to NCRPB as a Multi-Tranche Financing Facility for financing infrastructure projects in the National Capital Region (NCR) and its Counter Magnet Areas (CMAs). The loan agreement for the 1st tranche of US \$ 78 million was signed between ADB and NCRPB on 17.3.2011. Out of Tranche-1 loan amount of USD 78 million, USD 18.01 million has been cancelled. Board has already utilized the entire loan amount of USD 59.99 million (INR 352.06 crore) by the loan closing date of 31.12.2014 for tranche1. The rate of interest is based on 6 months Libor + Margin as may be determined by ADB based on their cost of funds of the relevant period payable half yearly. The repayment period is 25 years with 5 years moratorium for repayment of the principal amount. The commitment charges were payable up to December, 2014 on the undrawn loan amount @ 0.15% p.a.

5.1.2. **Reimbursement of Commitment Charges:** Two MMTC projects at Anand Vihar and Sarai Kale Khan have been dropped and the matter regarding reimbursement of commitment charges to the tune of Rs.69,95,613.81 up to 31.01.2013 being borne & paid by NCRPB to ADB on account of the two non-starter projects of the Transport Department, Govt. of NCT of Delhi have repeatedly been taken up. Inspite of repeated reminders & discussions in the 60th PSMG-I meeting held on 15.07.2021 and preceding PSMG-I meetings, the same are still to be paid by the Transport Department, GNCT Delhi.

Proposal is placed before the Group for information.

5.1.3. **Debt Service:** Board has been making regular payments of its dues to ADB. So far, Board has made payment of Rs. 42.40 cr. (\$ 6.22 million) to ADB on account of interest and commitment charges. Further, Board has repaid an amount of Rs. 61.94 cr. (\$8.80 mn) towards principal outstanding to ADB as on February, 2022. The total outstanding loan is USD 51.20 million (Rs. 386.50 Cr.) as on 28th February 2022.

Proposal is placed before the Group for information.

5.2 <u>KfW - (German Development Bank):</u> Loan agreements of Euro 100 million + Euro 1 million Grant for environment friendly schemes in the water supply, sewerage, drainage, solid waste management and urban transport Sectors to National Capital Region Planning Board were signed on dated 9.2.2012 & 30.3.2012 respectively. The repayment period is 15 years with a 5 years moratorium for repayment of the principal amount. The loan is at fixed rate of Interest @1.83% p.a. A total amount of Euro: 100 million (Rs. 745.99 Crores) has been claimed & disbursed by KfW to the Board. The commitment charges were payable @ 0.25% p.a. up to December, 2016 and subsequently @ 0.40% p.a. w.e.f. January 2017 to December, 2018 on the undrawn loan amount.

The 60th Meeting of the Project Sanctioning & Monitoring Group–I (PSMG-I) was held at 3.30 PM on 15.07.2021 under the Chairmanship of Secretary (HUA), Ministry of Housing & Urban Affairs, Government of India through Video Conferencing.

The list of the participants is enclosed as Annexure-I.

Member Secretary, NCRPB welcomed the participants and initiated the discussion with the permission of the Chair.

Agenda Item No. 1: Confirmation of the Minutes of the 59th Meeting of the PSMG-I held on 28.09.2020

1.1 The Minutes were confirmed.

Agenda Item No. 2: ATR of 59th PSMG-I meeting decisions

2.1 Action Taken Report on the decisions of the 59th Meeting of the PSMG-I held on 28.09.2020 was noted and following points were discussed:-

2.2 **Item No. 2.2(i) of ATR:** The Chair was briefed that the commitment charges are still unpaid by the Transport Department, GNCT of Delhi. The Chair inquired the status from Special Commissioner, GNCT of Delhi and advised to refund the commitment charges to NCRPB as the same were already paid by NCRPB to Asian Development Bank(ADB) against the MMTC projects which were approved in the 44th PSMG-I meeting held on 25.11.2009. The funds for these projects were earmarked by NCRPB but were not availed by Transport Department resulting in payment of commitment charges to ADB by NCRPB.

The representative assured to look into the records and process the payment of commitment charges to NCRPB.

2.3 Item No. 5.1 to 5.6 of ATR: New Project Proposals submitted to NCRPB with Loan Requests

2.3.1 The Group noted the status as presented in the Agenda that the first installments for all 06 projects sanctioned in the 59th PSMG-I have been released by NCRPB.

Agenda Item No. 3.1: Phase-II - Development of Integrated Aviation Hub, Hisar

3.1.1 The Group considered a loan assistance of Rs. 700 Cr. i.e. upto 75% of the project cost of Rs. 946 Cr. for the said project proposal as per agenda details given below:-

3.1.2 After deliberation, the Group accorded approval for financial assistance on the project proposal of **Phase-II - Development of Integrated Aviation Hub, Hisar** subject to furnishing of the following to NCRPB:-

- i. SFC approval and
- ii. Adequate Guarantee for the loan {(security proposed to be offered (State Guarantee/ Bank Guarantee @ 133.33% of the loan)} against the loan drawal from NCRPB. In case of direct loan to State Government backed with State Guarantee, an undertaking with regard to budget provision for repayment of loan/interest would be required.

3.1.3 Additional Chief Secretary, Finance, Government of Haryana assured the Group that SFC approval and adequate State guarantee shall be provided.

3.1.4 Further, issuance of administrative sanction by the Board is also subject to the fulfilment of the following criteria and providing of the applicable information / document:-

- i. Necessary required clearances should be arranged by IA in a timely manner and IA should ensure that the project should be implemented as per the schedule.
- ii. Land required for project implementation should be in the possession and name of the IA.
- iii. Requisite necessary statutory clearances from all Departments which are involved in the project implementation should be taken by the IA in a timely manner so that the project implementation should not face any hurdle during implementation including Approval of the Civil Aviation Department/DGCA of GOI and Notification of Counter Magnet Area.
- iv. Requisite Social & Environmental Reports, as applicable.
- v. Any other compliance as required by NCRPB during the course of the project implementation.

- vi. Requisite administrative & financial approvals for the revised estimates (if any) to be provided by Civil Aviation Haryana.
- vii. Any cost increase over and above the current estimates shall be borne by the agency and all efforts to complete the projects be ensured accordingly.
- viii. Commitment Charges shall be leviable as per Board's policy on non drawal or delayed drawal of funds.
- ix. Member Secretary, NCRPB may be authorized to take a decision in case of any issue which may arise in terms of technical feasibility, compliance of Statutory and Environment & Social requirements for the aforementioned project.

Agenda No 4: Proposal of Haryana Government for SDG Economic Recovery Bonds to be raised through eligible Central PSUs

4.1 The Chair was briefed about the proposal of Haryana Government to raise the SDG Economic Recovery Bonds through NCRPB. After detailed discussion and deliberation, the Group opined that the proposal is not feasible for execution as it will be against the mandate of NCRPB and advised the representative of Government of Haryana to approach NCRPB seeking financial assistance for individual projects. It was advised that State Guarantee can also be considered as security from State Department Implementing Agencies like Corporations etc.

5.1 The Group noted the status as presented in the Agenda including intimation of PWD Rajasthan regarding various road projects for Rs. 997.16 Cr.

Agenda Item No. 6: Review of Projects financed by the NCR Planning Board

Agenda Item No. 6.1: Project-wise information of projects where Completion Certificate has been received and may be declared as completed

6.1.1 The Group noted the status and approved the completion of the 06 projects as presented in the Agenda.

Agenda Item No. 6.2: Project-wise information of delayed projects where time extension has been sought

6.2.1 The Group was apprised that total 35 projects have sought extension in time and that the extension is justified. Of these 35 projects,11 pertain to Haryana, 16 to Rajasthan, 2 to Uttar Pradesh, 1 to Delhi and 5are from CMA, Jaipur.

6.2.2 The Group approved the extensions in time for the projects as presented in the Agenda and further suggested constitution of a committee under the Chairpersonship of Additional Secretary (D&UT), Ministry of Housing and Urban Affairs, GOI to present a draft policy with consent of all the NCR participating States in the next meeting regarding extension of time for delayed projects.

Subsequently, it was suggested that the average rate of interest on market borrowing of the State during Financial year-2021-22 is so far 6.90% only.

2. Thus, it is suggested that the proposed rate of interest may be reduced at par with the market borrowing rate of the Government of Haryana which is 6.90% so far and forward your consent accordingly to accord necessary approval by the Finance Department, Government of Haryana.
