#### Introduction

3.1.1 The Board has received request for sanction of financial assistance for Rs.265.00 Cr. for the new project "Strengthening & Energising Road Network in Bharatpur" from Bharatpur Development Authority (BDA), Rajasthan. The DPR for Rs. 265 Cr. and proposal for raising loan for Rs. 265 Cr. has been approved by BDA in its 2nd Meeting held on 03.04.2025. Also, the Concurrence of the State Government for obtaining loan of Rs.670 Cr. (consolidated amount including this project) from NCRPB has been issued by Govt of Rajasthan vide dated 16.04.2025. Copy of Administrative and Financial approval of Government of Rajasthan is at **Annexure-3.1/I.** 

#### **Project Details**

- 3.1.2 Bharatpur Development Authority (BDA) has prepared a detailed Project Report (DPR) for Strengthening & Energising Road Network in Bharatpur. The proposal is presented to the National Capital Region Planning Board (NCRPB) for funding. The project will be executed by Bharatpur Development Authority (BDA).
- 3.1.3 The total Estimated Project Cost is Rs. 265 Crores. The timeline of the Project is 24 months as it will be executed in phases. The funding of the project is loan-based as per the NCRPB policies for the development of NCR.
- 3.1.4 IA has informed that no land acquisition is required for the said project.

#### 3.1.8 Benefits to be generated

The main benefits addressed by BDA in Bharatpur are the development of a major sector network which will enhance both intra-city and inter-city connectivity, providing a seamless navigation experience. The network will also ensure smooth assess to major highways, further integrating Bharatpur into regional transportation framework

#### 3.1.9 Brief Assessment

NCR Planning & Monitoring Cell (NCRPMC), Rajasthan initially vide its letter dated 16.04.2025 had forwarded project proposal of "Key Infrastructure projects of Bharatpur Development Authority" for financial Assistance from NCRPB in Bharatpur with an estimated cost of Rs. 670.00 Cr. comprising combined project works of Drainage Network (Rs. 205.00 Cr.), Roads and Commercial Infrastructure Development (Rs. 265.00 Cr.) including shifting of Sarso Mandi (Rs. 200.00 Cr.) in a single DPR.

The said project proposal was examined inhouse by NCRPB and conveyed its observations to NCRPMC Rajasthan vide email dated 13.05.2025 to provide separate revised DPRs along with requisite information and documents for further examination.

NCRPMC, Rajasthan has provided revised separate DPR with their Assessment Note to NCRPB for the project proposal of Strengthening & Energising Road Network with estimated cost of Rs. 265.00 Cr. on 22.05.2025. Further, NCRPMC submitted the required ESMS certificate on 02.06.2025. Further, the said project does not fall in NCZ and no land acquisition is required for the said project. IA has offered State Guarantee as Security for the said project. IA has sought loan for Rs.265 Cr. which is 100% of the estimated cost of the project, however, NCRPB has restricted the loan for Rs.198.75 Cr. being 75% of the estimated cost as per NCRPB provisions. The applicable rate of interest is 7.00% (quarterly compounded).

#### 3.1.10 Proposal for consideration of the Group

The project has been appraised in NCRPB and is being recommended for approval by PSMG-I subject to the fulfilment of the following criteria: -

- i) Member Secretary, NCRPB may be authorized to take a decision in case of any issue which may arise in terms of technical feasibility, compliance of Statutory and Environment & Social safeguard requirements for the aforementioned project.
- ii) Necessary required clearances/ NOCs, if any, should be arranged by IA in a timely manner and IA should ensure that the project should be implemented as per the schedule.
- iii) Requisite necessary statutory clearances/ NOCs, if any, from all Departments which are involved in the project implementation should be taken by the IA in a timely manner so that the project implementation should not face any hurdle during implementation.

#### 3.2.8 Benefits to be generated

i. The main benefits addressed by BDA in Bharatpur to improve drainage, prevent waterlogging and enhance water flow. Desilting will clear debris, while canaling will reinforce of drain's structure. Waterfront development will create green spaces, pedestrian pathways boosting urban aesthetics and community engagement. These measures will increase food resilience, improve functionality and elevate the city livability.



ii. To solve the issue of severe waterlogging zone wise implementation of the plan is proposed. It will make city flood resilient and improve public health and safety.

#### 3.2.9 Brief Assessment

- i. NCR Planning & Monitoring Cell (NCRPMC), Rajasthan initially vide its letter dated 16.04.2025 had forwarded project proposal of "Key Infrastructure projects of Bharatpur Development Authority" for financial Assistance from NCRPB in Bharatpur with an estimated cost of Rs. 670.00 Cr. comprising combined project works of Drainage Network (Rs. 205.00 Cr.), Roads and Commercial Infrastructure Development (Rs. 265.00 Cr.) including shifting of Sarso Mandi (Rs. 200.00 Cr.) in a single DPR.
- ii. The said project proposal was examined inhouse by NCRPB and conveyed its observations to NCRPMC Rajasthan vide email dated 13.05.2025 to provide separate revised DPRs along with requisite information and documents for further examination.
- iii. NCRPMC, Rajasthan has provided revised separate DPR with their Assessment Note to NCRPB for the project proposal of Strengthening & Energising Drainage Network with estimated cost of Rs. 205.00 Cr. on 22.05.2025.
- iv. Subsequently, NCRPB communicated further observations viz. ESMS, EMP, clarification on existence of sewerage system and falling of discharge of the proposed drains into existing ponds/water bodies and funds for Rs. 5 Cr. released by DoE under SASCI 2024-25 for Girraj Canal one of the components of this project to NCRPMC on 29.05.2025. NCRPMC submitted requisite ESMS certificate and response on 02.06.2025.
- v. NCRPMC, Rajasthan has provided revised separate DPR with their Assessment Note to NCRPB for the project proposal of Strengthening & Energising Drainage Network with estimated cost of Rs. 205.00 Cr. on 22.05.2025. Further, NCRPMC submitted the required ESMS certificate on 02.06.2025. Further, the said project does not fall in NCZ and no land acquisition is required for the said project. IA has offered State Guarantee as Security for the said project. IA has sought loan for Rs.205 Cr. which is 100% of the estimated cost of the project, however, NCRPB has restricted the loan for Rs.150 Cr. being 75% of the estimated cost (Rs.200 Cr. after deduction Rs.5 Cr as approved under SASCI) as per NCRPB provisions. The applicable rate of interest is 7.00% (quarterly compounded).
- vi. On further queries, BDA has sent clarifications dated 29.05.2025 wherein among other points, following have been specifically clarified:

  BDA has included Environmental Monitoring Plan and Environmental Management Plan (EMP) for Drainage Network in Bharatpur. Further implementation of the EMP is by embedding its mitigation and monitoring components into every phase of the project-planning, design, execution, and post-construction. No sewage or solid waste is proposed to be conveyed through the storm water drain age system. Furthermore, the discharge from the storm water drains, as proposed in the DPR, does not flow into any natural water bodies or ponds. Instead, the outflow is strategically directed into designated main drains or other connected storm water drains, which are engineered to handle surface runoff safely and efficiently. A sum of 5 crore sanctioned as an interest-free loan from SASCI is specifically



intended for the Girraj Canal component and shall not be utilized for any other purpose. Fresh and consolidated certificate had also been enclosed.

#### Agenda Item No. 67/4: Status of Projects received from RRVPN Ltd. Rajasthan

- 4.1 Following Five Project Proposals of RRVPN Ltd. have been received from NCR Planning & Monitoring Cell (NCRPMC), Rajasthan for financial consideration from NCRPB as per details given below:
  - i. Financial assistance for project profile of 132/33 KV, 1x31.5 MVA GSS at Anjari Dangika (Distt-Deeg) with Associated works project in Rajasthan Sub-Region of NCR of by RRVPN ltd., Rajasthan with Estimated Cost for Rs.27.37 Cr.
  - ii. Financial assistance for project profile of 220/132 kV GIS at Gokul Nagar, Kalwar Road (Distt. Jaipur) with Associated works project in Rajasthan Sub-Region of NCR of by RRVPN ltd., Rajasthan with Estimated Cost for Rs.189.05 Cr.
- iii. Financial assistance for project profile of 132/33 kV, 1x50 MVA GSS at Semli [Distt.-Deeg] with Associated works project in Rajasthan Sub-Region of NCR by RRVPN ltd., Rajasthan with Estimated Cost for Rs.25.18 Cr.
- iv. Financial assistance for project profile of 132 KV S/C XLPE underground copper cable between 220 KV GSS Sitapura and 132 KV GSS Sitapura with associated works project in Rajasthan Sub-Region of NCR by RRVPN ltd., Rajasthan with Estimated Cost for Rs.8.08 Cr.
- v. Financial assistance for project profile of 220/132 KV, 1x200 MVA and 132/33 KV, 1x40/50 MVA GSS at Ghiloth (Distt-Kotputli-Behror/Alwar) alongwith associated works project in Rajasthan Sub-Region of NCR by RRVPN ltd., Rajasthan.

#### **Status:**

- 4.2 These projects fall under Rajasthan sub region of NCR/CMA Jaipur notified area as confirmed by NCRPMC Rajasthan. NCRPMC has given assessment note of all the above projects recently (30.04.2025, 26.05.2025 & 27.05.2025) and at present these project proposals are under examination at NCRPB and various observations viz. ESMS requirements, approval of construction of Residential Buildings, staff quarters from their Board, Security Offered, etc have been made. Thus, these project proposals are not ready to be placed before the Group.
- 4.3 After examination and receipt of required information and documents from NCRPMC/IA, these project proposals will be placed before next PSMG-I.

Agenda Item No. 67/5: Time extension approval for five ongoing Functional Plans i.e. (i) Urban Regeneration, Housing and Slum Free NCR, (ii) Education and Skill Development, (iii) Health Sector (iv) Tourism and Heritage and (v) Dairy Sector.

- 5.1 The matter relates to Extension of Time (EoT) for the on-going work of 04 Functional Plans under Draft RP-2041 i.e., (i) Urban Regeneration, Housing and Slum Free NCR, (ii) Education and Skill Development, (iii) Health Sector and (iv) Tourism and Heritage was discussed and approved in the 65<sup>th</sup> (29-11-2024) meeting of the PSMG-I, since the timeline in the signed agreement for the respective FPs have expired and subsequently EoT has been requested by the respective Consultants.
- 5.2 In previous years CAG had raised some audit observations regarding timely preparation of Functional Plans w.r.t. Regional Plan-2021. Thus, NCRPB has taken proactive steps and placed the proposals for above mentioned Functional Plans w.r.t. Regional Plan-2041 (Draft) before the 62<sup>nd</sup> (31-03-2023) and 63<sup>rd</sup> (22-08-2023) meeting of PSMG-I (as tabulated below). PSMG-I, which includes representation from all NCR States including Haryana, was apprised that *Section 16 of the NCRPB Act, 1985 provides that after the Regional Plan has come into operation, the Board may prepare, with the assistance of the Committee, as many Functional Plans as may be necessary for the proper guidance of the participating States and of the Union Territory*. PSMG-I deliberated in detail and approved the proposals with the following major conditions (copy of concerned Agenda Item and Minutes as per **Annexure-5/I**). It is notable that the list of participants, including participant from four states for 62<sup>nd</sup> and 63<sup>rd</sup> PSMG-I meetings are respectively at **Annexure-5/II** and **Annexure 5/III**:
  - a) As NCR delineation is in progress, in case of any change in NCR area, the bid / payment of /to successful bidders will be revised proportionately/ on pro-rata basis as per the revised NCR area.
  - b) Some changes/ modifications are also expected in the Draft Regional Plan-2041 as published on NCRPB website. These changes, if available before finalizing the bids, will be considered and communicated to the successful bidders during the exercise of Functional Plan studies/preparation.
  - c) Final approval on draft Functional Plan(s) prepared by the successful bidder will be accorded only after notification/publication of the Final Regional Plan-2041 for NCR.
  - d) One bidding entity shall not be awarded more than two works (FPs).
- 5.3 Further, in the 63th PSMG-I, Para 3.1 The Group directed that NCRPB should ensure that these Functional Plans, being prepared, should be very useful and implementable. Group also directed that, to ensure the quality, the reports right from Inception Report should be checked carefully and only after duly verifying the quality, usefulness, implementability of the report/s and its acceptance & approval, the payment should be released. Accordingly, the group decided that the "Deliverables and Time/Payment Schedule" should be revised as under: -

- 5.4 Inception Reports of all these Functional Plans were approved by NCRPB as finalised by all the Consultants, as per the recommendations of the respective Consultancy Review Committees (CRCs). Further, the Draft Interim Reports have also been prepared/ submitted in all cases and CRCs and NCRPB comments on these Draft Interim Reports have also been sent to the respective Consultants. Further work on each of them is in progress.
- 5.5 Since the work of draft Functional Plans is subject to <u>approval of the Final RP-2041</u> and carrying out necessary examination/ checking, to achieve required quality of each of the Draft Interim Report, as well as holding meetings of the respective CRCs, has taken substantial time, the Consultants have requested for extension of time, as following:

- 5.6 It is notable that approval of earlier extension to Consultants was also considerably delayed after receipt of their requests. Further, RP-2041 has not yet been finally published and since the Consultants have already provided Draft Interim Reports and incurred expenditure, their request for further extension-in-time may be considered. It is expected that the submitted Draft Interim Reports with due iterations are likely to be approved by respective CRCs and NCRPB by the time of final publication of RP-2041. Hence, extension of further time beyond final publication of RP-2041 as per respective contracts (i.e. time allowed in contracts from Interim Report to Final report) seems reasonable.
- 5.7 Though different consultants have requested for different time extensions, it is appropriate to have similar principle for all. Further, proposal for Dairy Functional Plan is also being included on same principle though the consultant (NDDB) has not yet formally sought extension in writing.

#### **Proposal:**

To accord further Extension of Time for ongoing 05 Functional Plans for a period of One year from the date of issuance of approval of PSMG-I <u>OR</u> 34 weeks from the date of publication of RP-2041 (in case of FP for Urban Regeneration, Housing and Slum Free NCR)



and 23 weeks from the date of publication of RP-2041 (in case of FP for Education & Skill Development, Health Sector, Tourism & Heritage and Dairy Sector), WHICHEVER IS EARLIER.

## SUPPLEMENTARY : PROPOSAL REGARDING PREPARATION OF AGENDA ITEM NO. 62/SA-1 FUNCTIONAL PLANS FOR NCR - 2041.

- 1.1 Section 16 of the NCRPB Act, 1985 provides that after the Regional Plan has come into operation, the Board may prepare, with the assistance of the Committee, as many Functional Plans as may be necessary for the proper guidance of the participating States and of the Union Territory.
- 1.2 The Draft Regional Plan-2041 (RP-2041) for NCR has been prepared after deliberations and discussions with all the NCR participating States and other stakeholders. The Draft RP-2041 was approved by the NCR Planning Board in its 41st Meeting held on 12.10.2021 for inviting objections and suggestions as per Section 12(1) of the NCRPB Act, 1985. Accordingly, the Draft RP-2041 was published for inviting objections and suggestions on 09.12.2021. Thereafter, the Draft RP-2041 was proposed to be discussed in the 42nd Board Meeting scheduled to be held. However, the said meeting was postponed due to unavoidable circumstances.
- 1.3 The Planning Committee of the Board, in its 71st meeting held on 04.01.2023, noted that in anticipation of approval of Draft RP-2041, NCRPB has initiated advance action regarding conducting studies/preparation of Functional Plans (FPs), which are generally time consuming, with a proviso that the FPs shall be finalized only after the Regional Plan-2041 is duly notified. A caveat was made in the RFQ-cum-RFP Document that 'as NCR delineation is in progress, in case of any change in NCR area, the bid / payment of / to successful bidders will be revised proportionately / on pro-rata basis as per the revised NCR area'. The FPs works include:
  - a) Preparation of FPs through Asian Development Bank (ADB) Technical Assistance (TA) TA was signed with ADB in Nov. 2021, under which ADB floated EOI for recruitment of consultants for preparation of following 03 Functional Plans:
    - (i) Functional Plan for Transport, Economic Nodes and Industrial Corridor
    - (ii) Functional Plan for Water Management and Waste Management, and
    - (iii) Functional Plan on Climate and Disaster Resilience

The EOI was published by ADB in March 2022 against which 16 proposals were received and 06 consulting firms were shortlisted for next stage.

- b) NCRPB with its in-house initiative has floated RFQ-cum-RFP for following 06 Functional Plans in June 2022, extended till 21st Nov. 2022:
  - (i) Functional Plan for Urban Regeneration, Housing and Slum Free NCR
  - (ii) Functional Plan for Smart and Digital NCR
  - (iii) Functional Plan for Education and Skill Development
  - (iv) Functional Plan for Health Sector
  - (v) Functional Plan for Tourism and Heritage
  - (vi) Functional Plan for Dairy Sector

- 1.4 In this regard, it is to apprise that from aforementioned in-house initiative of NCRPB for 06 FPs, bidding process has been completed for 'FP on Urban Regeneration, Housing and Slum Free NCR'. Whereas, re-tendering Notice/Advertisement for remaining 05 FPs has been published on 18.03.2023.
- 1.5 Regarding 'FP on Urban Regeneration, Housing and Slum Free NCR' total 06 bids were received which were technically evaluated by the Technical Evaluation Committee (TEC), chaired by Prof. (Dr.) PSN Rao, Ex-Director, SPA-Delhi and having members from all NCR participating States. Out of 06, the TEC found that <u>02 bidding entities could not qualify the Technical criteria</u>. Accordingly, 04 bidding entities who qualified the Technical evaluation were considered for financial evaluation.
- 1.6 Based on the recommendation of the Financial Evaluation Committee (FEC), chaired by Director (A&F), NCRPB, and Combined Technical and Financial Score (CTFS), following the Quality and Cost Based Selection (QCBS) weightage of 80:20, M/s. IPE Global Ltd. has been found as qualifying bidder (L1) for preparation of 'FP on Urban Regeneration, Housing and Slum Free NCR'.
- 1.7 As per the Terms of Reference (ToR), the work is to be completed in 54 weeks, subject to approval based on final publication of the RP-2041. The total consultancy cost including GST quoted by qualifying bidder (L1) is Rs. 2,34,82,000/-.
- 1.8 The 'FP on Urban Regeneration, Housing and Slum Free NCR' will be a detailed document for the guidance of NCR participating States towards addressing various requirements of housing, urban regeneration & rejuvenation, planned habitat, housing development, making NCR slum-free, including other aspects like TP Scheme, Land Pooling models, Local Area Plan, TOD, TDR, Housing Technologies, transformation of urban areas, rental housing, vacant properties & stalled project, support infrastructure, etc., in the overall framework of the RP-2041.

## Supplementary Agenda Item: Financial assistance for the Project- 'Phase-II - No. 67/SA-1 Development of Integrated Aviation Hub, Hisar.'

- 1.1 Project Sanctioning and Monitoring Group-I (PSMG-I) in its 60<sup>th</sup> Meeting held on 15.07.2021 had sanctioned financial assistance of Rs. 700 Cr. at interest rate of 8.50% p.a. for the project "Phase-II Development of Integrated Aviation Hub, Hisar" being implemented by Civil Aviation Department (CAD), Haryana with total estimated cost of Rs.946.00 crore. As per PSMG-I approval, issuance of Administrative Sanction by NCRPB was subject to the fulfillment of certain conditions including furnishing of SFC approval and adequate Guarantee for loan by CAD, Haryana. CAD, Haryana had provided the SFC approval on 17.01.2023.
- 1.2 In between, CAD, Haryana submitted a request on 06.10.2021 to review the interest rate for the said project from 8.50% to 6.90% (Annexure-I).
- 1.3 The request of CAD Haryana to review the interest rate from 8.5% to 6.9% was placed before the 61st Meeting of PSMG-I held on 24.03.2022. 61st PSMG-I in its deliberations discussed in detail the financing structure of NCRPB and recommended to the Board a revision in the NCRPB's financing structure.
- 1.4 The 42<sup>nd</sup> Board Meeting of NCRPB was scheduled to be held on 05.07.2022 as per MoHUA letter dated 10.06.2022. However, the meeting was postponed vide MoHUA email dated 04.07.2022. The status of the matter was also placed in 62nd PSMG-I held on 31.03.2023. Subsequently, NCRPB made multiple efforts to convene the Board Meeting for approval of the above proposal of PSMG-I. However, as no Board Meeting was held, proposal including above recommendations of 61st PSMG-I was sent to Secretary, MoHUA vide U.O. Note dated 10.01.2024 and then 09.02.2024 for approval of the proposal through circulation from the Board members.
- 1.5 MoHUA vide letter dated 14.02.2024 conveyed the approval of Hon'ble Minister HUA & Chairman, NCRPB to seek the approval of Hon'ble members of the Board through circulation.
- 1.6 The matter was again placed in the 64th Meeting of PSMG-I held on 27.02.2024. Accordingly, proposal for revision in the financing structure of NCRPB, as recommended by 64<sup>th</sup> PSMG-I was circulated by NCRPB to Board Members vide letter dated 27.02.2024 and subsequently vide Circular Resolution No. 4/2 dated 20.12.2024. Consent/comments of Chief Secretary, Haryana received on 01.10.2024 while consent Hon'ble MoS and Hon'ble CM, Haryana received on 25.11.2024. Board Members from Haryana had requested to include the category "Indian Railways" alongwith projects of Metro/Rapid rail/RRTS/Airports having interest rate @7% p.a. regarding financial assistance given by NCRPB. The consent/assent of Hon'ble CM, GNCTD was received on 17.12.2024.
- 1.7 After approval of the Board Members, NCRPB vide UO Note dated 20.12.2024 requested Secretary, MoHUA for kind approval of the Hon'ble Chairman, NCRPB. MoHUA vide letter dated 12.03.2025 (**Annexure-II**) conveyed the approval of Hon'ble Chairman, NCRPB for the same. Accordingly, NCRPB circulated revised financing structure on NCRPB financial assistance vide letter dated 12.03.2025 and the applicable revised rate of interest for Airport projects has

become 7.00% pa (quarterly compounded) with loan tenure for 20 years including moratorium period of 5 years for repayment of principal amount.

- 1.8 Subsequent to revision of interest rate/financing structure, NCRPB issued Administrative Sanction Order on 18.03.2025 conveying sanction of loan of Rs.700.00 Cr. @ 7% (quarterly compounded) to CAD, Haryana with 1<sup>st</sup> instalment of Rs.300 Cr. alongwith detailed terms & conditions of loan. CAD Haryana was required to submit requisite loan documents including Loan Agreement, State Guarantee and Account Head details etc. to enable NCRPB to disburse scheduled 1<sup>st</sup> instalment of Rs.300 Cr. to Govt. of Haryana during the FY 2024-25.
- 1.9 In the event of non-receipt of any response from CAD Haryana, NCRPB again requested them vide email dated 27.03.2025 to submit the requisite loan documents and account head details followed by constant telephonic communications with the concerned officers of CAD Haryana and Finance Department of Govt. of Haryana. After a rigorous follow-up with CAD Haryana, NCRPB has received Account Head details at 11:03 p.m. and State Guarantee at 11:33 p.m. through email on 31.03.2025. The major head of account details was identified; however, the subhead was not reflected on the E-Grass Portal of Govt. of Haryana to transfer the funds to the Govt. Treasury.
- 1.10 The sub-head (as per account details provided by CAD Haryana) got reflected on the portal very late at 11:49 p.m. (31.03.2025). NCRPB officials immediately generated challan at 11:52 p.m. and requested SBI to release the funds. However, due to non-reflecting the e-Challan in their (SBI) server, which usually takes couple of hours, the payment could not be executed by midnight of 31.03.2025 and EOD (End of Day) of FY ending happened in SBI server. The requisite loan documents (incl. loan agreement and State Guarantee) in original are still awaited from CAD Haryana. Thus, CAD Haryana is yet to lift the 1<sup>st</sup> loan installment of Rs.300 Cr. (due in FY 2024-25) under the said project.
- 1.11 It is also learnt that Hon'ble Prime Minister has inaugurated the Hisar Airport on 14.04.2025.
