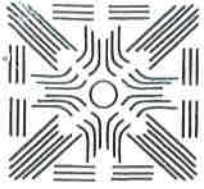

Subject: Appointment to the post of Stenographer Grade-D in the Pay Level-4 (₹ 25,500-81,100) (Revised as per 7th CPC) in the National Capital Region Planning Board (a statutory body under Ministry of Housing & Urban Affairs, Govt. of India).

With reference to your application for the post of Stenographer Grade-D and on the basis of examination held on 12.06.2025 and 13.06.2025, I am directed to inform you that the Competent Authority has approved to offer you appointment for the post of Stenographer Grade-D in the Pay Level-4 (₹ 25,500-81,100) as per 7th CPC pay matrix in National Capital Region Planning Board (NCRPB) on the following terms & conditions:-

- (i) You will be paid initially a Basic Pay of ₹ 25,500 per month in the Pay in the Pay Level-4 (₹ 25,500-81,100) as per 7th CPC pay matrix plus usual allowances, as admissible under the rules of the Board.
- (ii) You will be on probation initially for a period of two years from the date of joining the post of Stenographer Grade-D in NCRPB. The probationary period may be extended or curtailed at the discretion of the Competent Authority. During the probation period, the appointment may be terminated at any time without notice and without assigning any reasons thereof.
- (iii) You will not be entitled to any travelling allowance for reporting for duty or on termination of your appointment under the Board.
- (iv) Your appointment will be subject to the production of the following documents in original at your own expenses at the time of reporting for duty:-
 - (a) Documentary proof in support of date of birth (along with attested copy).
 - (b) Educational Qualification(s) & Experience Certificates (along with attested copy).

- (c) Certificate of character duly attested by a Gazetted Officer or by a District Magistrate or Sub-Divisional Magistrate in the enclosed form.
- (d) Medical certificate of health and physical fitness for service from Medical Superintendent of the Lady Harding Medical College, New Delhi.
- (e) Two copies of the enclosed Attestation form duly filled-in and certified by the prescribed authority as indicated therein.
- (v) If married, you will be required to sign a declaration that you have not more than one living spouse and if unmarried you will not marry a second time while your first spouse is alive save with the permission of the Competent Authority.
- (vi) You will be covered under New Pension Scheme of Ministry of Finance, Govt. of India, Department of Economic Affairs notified vide O.M. No. F.N/1(7)(2)/2003/TA/11, dated 07.01.2004 and other instructions issued by the government from time to time on the above issue, as applicable to the employees of the Board.
- (vii) You will have to take an oath of allegiance to the Constitution of India.
- (viii) The provisions of the Central Civil Services (Classification, Control and Appeal) Rules, Central Civil Services (Conduct) Rules and such other rules or executive orders as may from time to time be applicable to the employees of the Board, shall apply to the extent to which they are applicable to the appointment hereby offered and the decision of the Board as to their applicability shall be final.
- (ix) In regard to any other matter not specifically covered in foregoing paragraphs, you will be governed by the rules and orders as applicable to the employees of the Board.
- (x) The Board has no housing facility at present and, therefore, you will need to arrange for your accommodation yourself. However, you will be paid House Rent Allowance as per applicable rules in the Board.

If you are willing to accept the appointment on the above terms and conditions, you may give your acceptance to the above offer of appointment at the earliest or within three days of receipt of this letter.
